Terms and Conditions

Promotional Overview

Participants in "Verve Customer Re-Activation Promo" (The "**Promotion**") will be deemed to have accepted these Terms and Conditions ("**Terms & Conditions**") and agreed to be bound by them when participating in the Promotion. Participants automatically lose their eligibility to participate in the Promotion upon violation (or attempted violation) of these Terms & Conditions or the spirit of these Terms & Conditions.

For the purposes of this Promotion, the promoter is Verve Card Services Limited and with whom you are contracting ("We", "Us" and "Our").

1. Promotion Period

2. Territory

The Promotion will only be valid in the Federal Republic of Nigeria (hereafter called "Nigeria").

3. Eligibility to Participate

- 3.1. To be eligible to participate in the Promotion, you must:
 - 3.1.1.Be aged 18 years and above and possess full legal capacity;

- 4.3. For the purposes of this Terms and Conditions, non-cash Transactions shall mean all kinds of transaction at an Automated Teller Machine or payment for goods or services with your Verve® payment card through any electronic channel except cash withdrawal.
- 4.4. You understand and accept that any sums applied or expended by you in participating in this Promotion is non-refundable.

5. Disqualified Participants

- 5.1. Our officers, directors, employees, consultants or agents of or any of our subsidiaries, parent or associated companies, or any of our or their respective suppliers or vendors (including advertising, printing and publicity agencies) or any officers, directors, employees, consultants or agents of any entity connected with the Promotion, or relatives of any of the foregoing persons, "relative" shall include, but not be limited to, a spouse, partner, child or sibling and any person residing in the same household as any of the foregoing persons shall not be eligible to participate in the Promotion.
