# Terms and Conditions (T&Cs) FirstMobile Transaction Reward Promotion

#### I. Introduction

This Promotion is designed to reward 1,702 (one thousand, seven hundred and two) First Bank of Nigeria Limited ("FirstBank" or "the Bank") customers who transact on the FirstBank Mobile Application (FirstMobile) channels. The Promotion will run for a period of 2 (two) months with a total cash and non-cash reward of N36,000,000.00 (Thirty-Six Million Naira) (the "Promotion" or "Promo").

To qualify, the customer must use FirstMobile to consummate a varying number of transactions, which include Transfers, Airtime Purchases and Bill Payments ("Transactions"). Only transactions done via FirstMobile will qualify for the Promo.

The Promotion shall run from Monday, January 15th, 2024 – Friday, March 15th, 2024 ("Promo Period") and will only be valid in the Federal Republic of Nigeria (hereafter called "Nigeria").

### 2. Legal Agreement

These Terms and Conditions ("the Terms") apply to the FirstMobile Transaction Reward Promotion on the FirstMobile Channel hosted by FirstBank which can be accessed through any mobile device.

In these Terms and Conditions, "the Bank" "we", "us" or "our" refers to FirstBank and its successors, agents and assigns, while "you" or "your" refers to anyone participating in this Promo. These terms and conditions form a legal agreement between you and FirstBank and can only be amended by the Bank. By participating in the FirstMobile Transaction Reward Promotion, you confirm that you have read, understood, and agree to be bound by the terms and conditions contained herein, and subsequent amendments thereto as well as all applicable laws and regulations now existing or which may hereafter be enacted, issued, or enforced.

You agree to be bound by these terms and conditions ("the Terms"). You also agree that the Terms are supplementary to the other existing terms governing the banking relationship between you and the Bank and subsequent amendments thereto, including without limitation to the Bank's DATA PROTECTION POLICY STATEMENT (the Other Terms). You further confirm that you have read, understood, and agree to be bound by the Other Terms.

### 3. Promotion Dynamics

- a) The Promo runs for 2 (two) months, split into an 8 (eight) week period from Monday, January 15th, 2024 Friday, March 15th, 2024.
- b) A Customer can only win once.

  - i. <u>Category I</u>- Transact 5 (five) times a week and stand a chance to win N10,000 worth of airtime and data. 100 winners to emerge weekly for 8 weeks.

  - a) To be eligible for the Promotion, you must be a FirstBank account holder (Customer) and enrolled on the FirstMobile App.

  - c) The reward is open to transactions on Fund Transfers, Airtime Purchases and Bill Payments on the FirstMobile App.
  - d) Winners will be randomly selected.
  - e) Winners will be contacted or informed of their winnings via SMS, Push Notification and/or Email or any other channel to be determined by FirstBank in its sole discretion.
  - f) Winners shall be subsequently rewarded on a date and time and with an airtime value or cash in line with the promotion dynamics.
  - g) FirstBank reserves the right to disqualify a potential winner deemed ineligible (or who otherwise does not qualify to become a winner) and select another winner, provided always that the disqualified winner/ winner subject to substitution may seek recourse from the National Lottery Regulatory Commission
  - h) Prizes are only valid while the promotion lasts.
- 5. Participation in the FirstMobile Transaction Reward Promotion

- a) Participation in this Promo is voluntary, as such no customer is under any compulsion to subscribe during this period.
- b) To participate, kindly follow the instructions set out in the relevant Promo Communications that is circulated via the FirstMobile Application, FirstBank's Social Media Channels, or website (www.firstbanknigeria.com) or in the course of your discussion with our FirstContact Representative.

#### 6. Use of Data

FirstBank will collect personal data about participants including their name, phone numbers, e-mail addresses and information about participants. By participating in the Promo and providing us with your personal information, you expressly consent to us:

- (i) processing your personal information/data as may be required by FirstBank for the purpose of the Promotion and other promotional activities; and
- (ii) using any data or information obtained from you, including your personal data, and sharing same with other third parties, including our subsidiary companies, parent, affiliates, members of FBN Holdings Plc's Group (Related Parties) and any service provider(s) engaged by FirstBank for the purpose of the Promo.
- (iii) We reserve the right to publish the names and images of winners without prior notice.
- (iv) Participants acknowledge that countries where their personal data may be shared may not have data protection laws which are neither equivalent nor stricter than those of participant's country of residence.

### 7. Disclaimer and Indemnification

Each participant in the Promo agrees to release, discharge, indemnify and hold harmless FirstBank, the Related Parties, and each of their respective directors, officers, employees and shareholders from any and all liability, loss, damage or injuries to any person (including death) or loss of property of any kind sustained in connection with the participant's participation in the Promo or from participant's acceptance, receipt, possession and/or use or misuse of the Promo reward, or for any typographical or other error in the printing, offering or announcement of the prize.

FirstBank reserves the right at its sole discretion, to disqualify any agent who tampers with the entry process, and to cancel, terminate, modify, or suspend the Promo in whole or in part, at any time, without notice and disclaims any liability, claims or losses that may arise therefrom.

### 8. Exclusion and Limitation of Liability

arising from FirstBank's negligence), breach of these terms, cancellation, modification or suspension of the Promo or otherwise, even if such loss is foreseeable whether or not FirstBank has been notified of the possibility of loss occurring.
