

## Terms and Conditions (T&Cs) guiding the Atlantic Hotels & Suites Promo

### 1. Introduction

- iv. Check in Time: 1300hrs & Check out Time: 1100hrs
- v. 15% discount on Food and Beverage services consumed by the guests, at the restaurant/Bar staying at the restaurant (Alcoholic beverages are exempted from this discount)

- vi. The offer cannot be merged with any other offer of the hotel, and room booking is subject to availability and prior booking/confirmation from the hotel
